In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MD(Pharmacology) qualification for 02 seats in respect of students being trained at M E S Medical College, Perinthalmanna, Malappuram under Kerala University of Health Sciences, Thrissur**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.*
